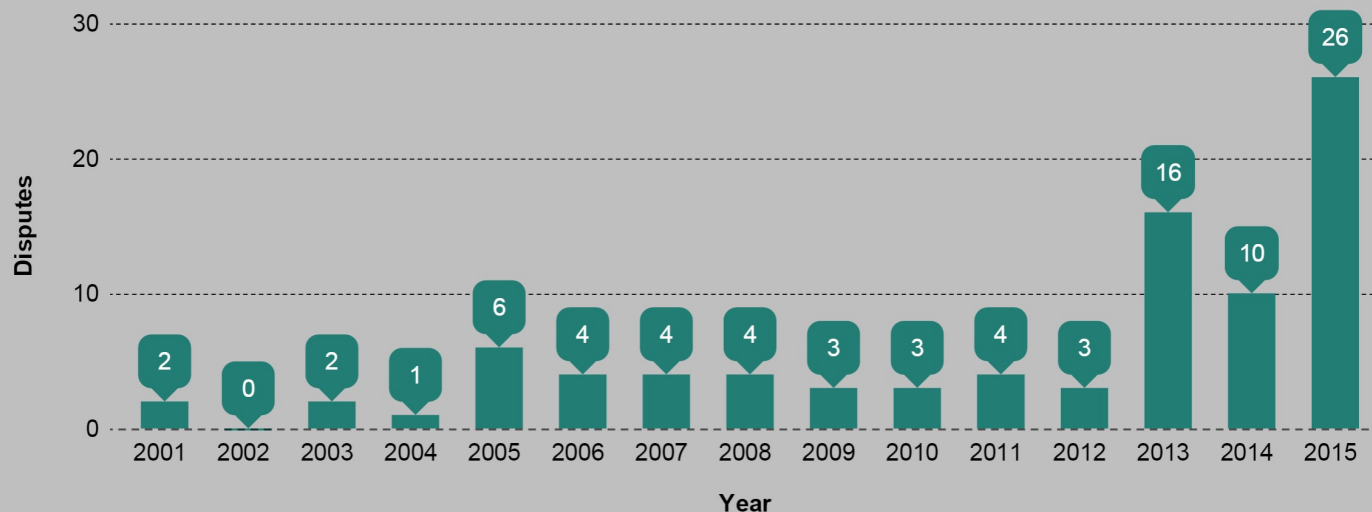
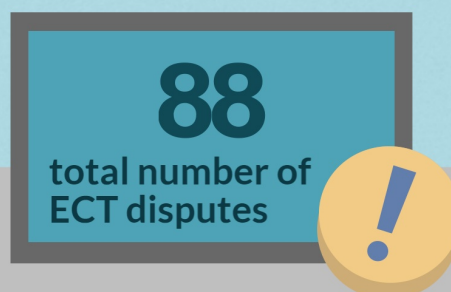
## **STATISTICS ON INVESTMENT DISPUTE SETTLEMENT UNDER THE ENERGY CHARTER TREATY**

- 1) The Energy Charter Secretariat regularly monitors the implementation of the ECT, including the investor-state dispute settlement mechanism under Article 26 of the ECT.
- 2) The following infographics represent a statistical information based on publicly available information.
- 3) Investment arbitration under Article 26 of the Energy Charter Treaty has increased considerably since 2013 and has reached the number of 88 proceedings in November 2015.

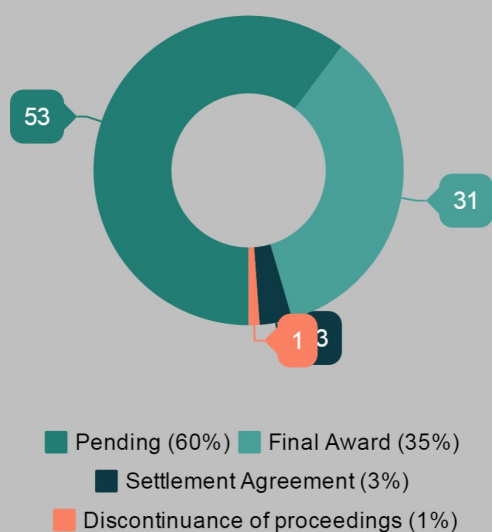
### Statistics on Investment Dispute Settlement under the ECT: Enforcing Regulatory Stability and Market Confidence in the Energy Sector

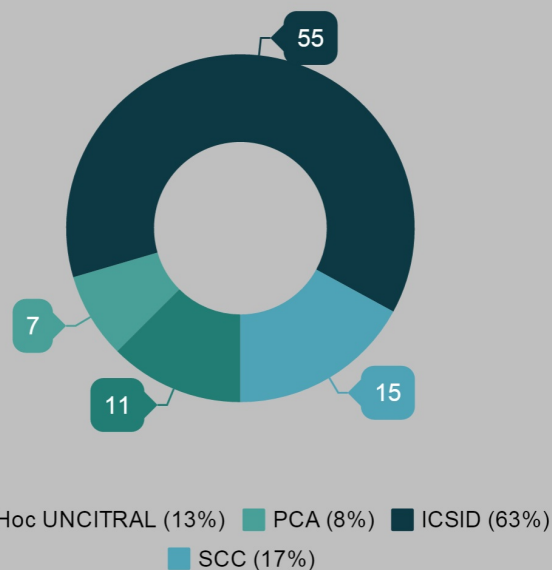
### Number of investment disputes under the ECT

Between 2001 and 2015, the number of investment disputes under the Energy Charter Treaty has reached a total of 88 known cases. A peak in disputes has been registered in the years 2013, 2014 and 2015.



### Status of Proceedings

Of all publicly known investment disputes under the ECT, 53 are pending, 31 have been concluded by arbitral award, while only 3 have been settled by the parties.



### Arbitral institutions

Of all cases, 55 have been brought before ICSID, 15 before SCC, 11 before Ad Hoc UNCITRAL tribunals, and 7 before the PCA.

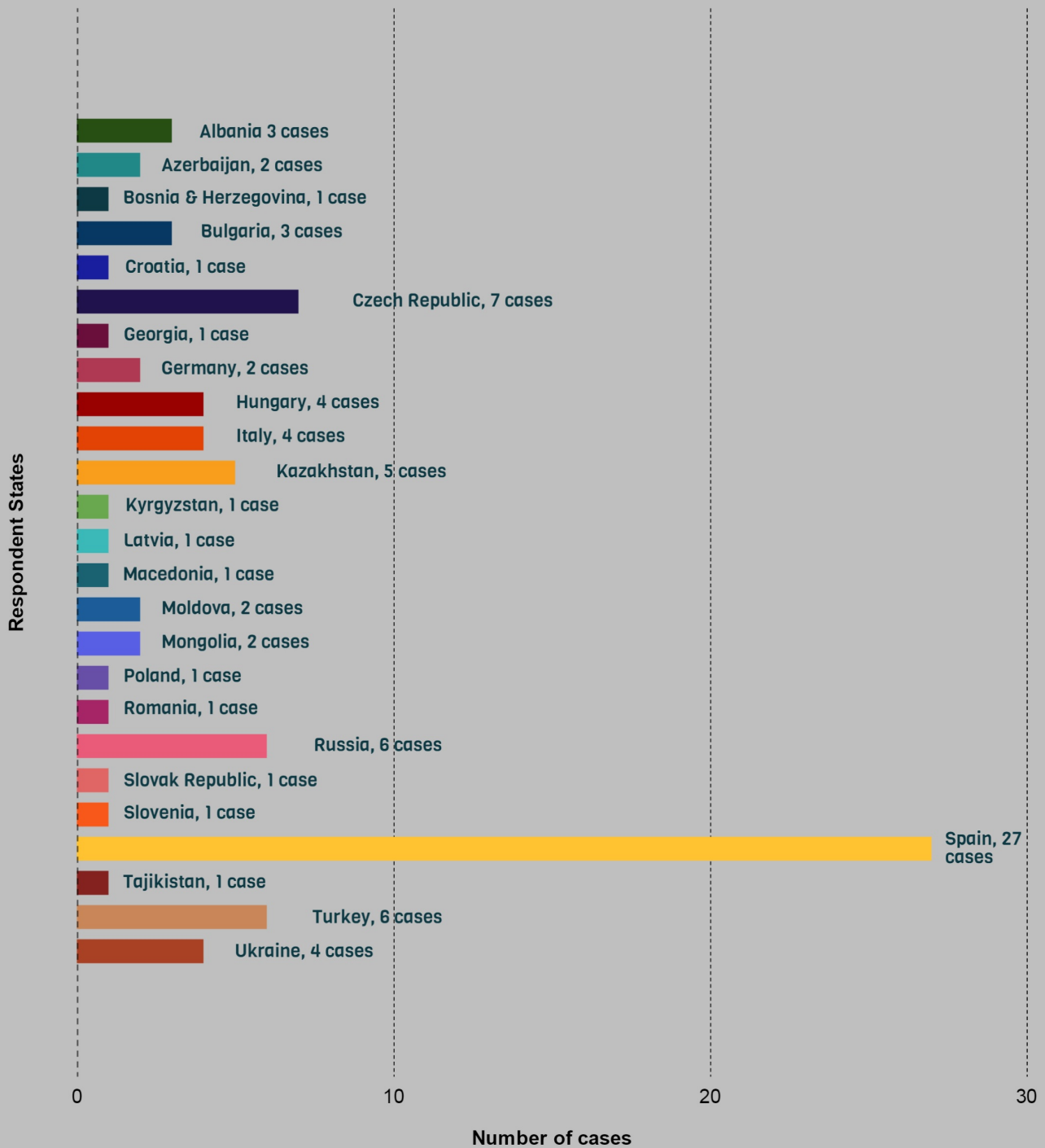

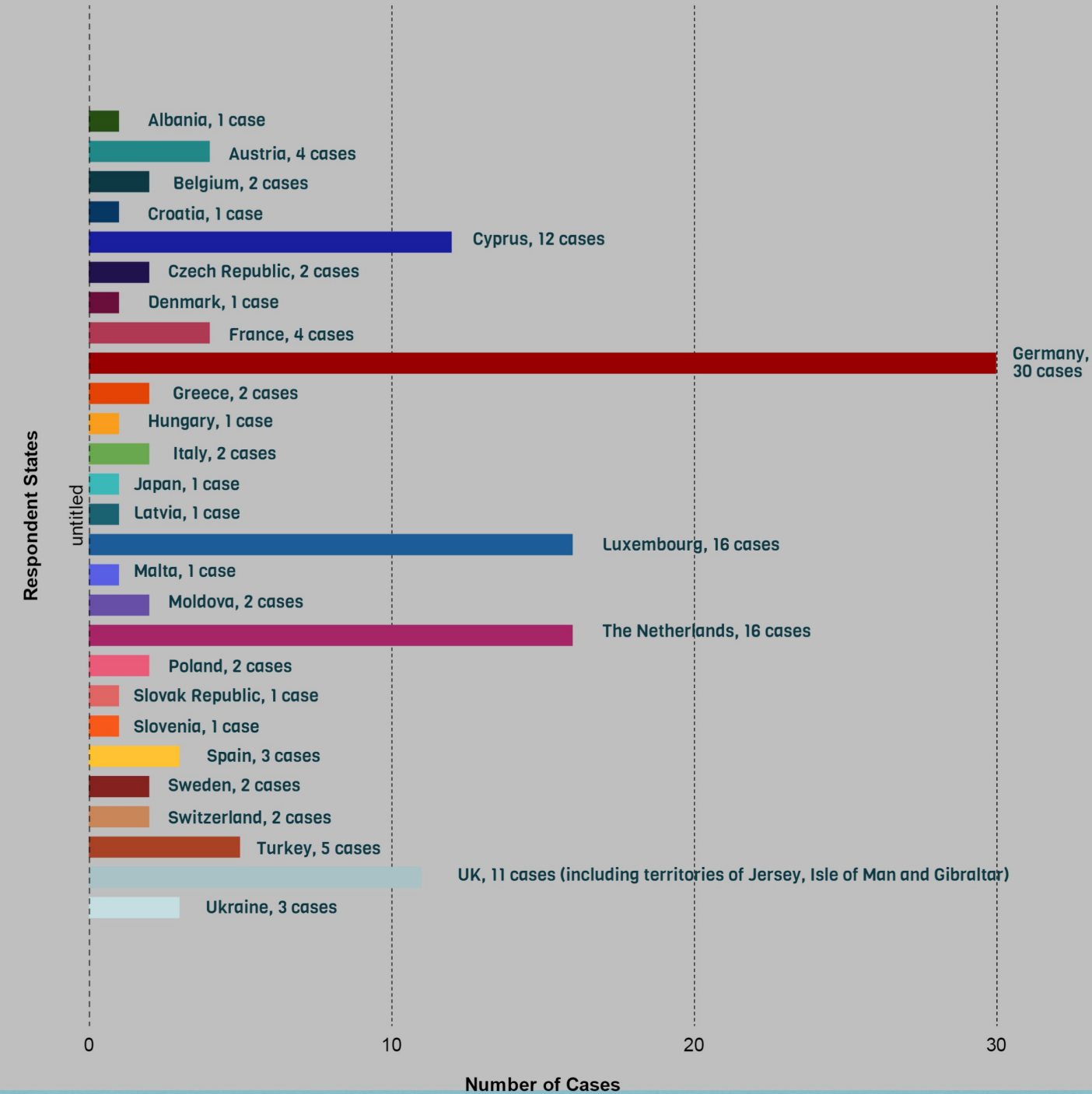

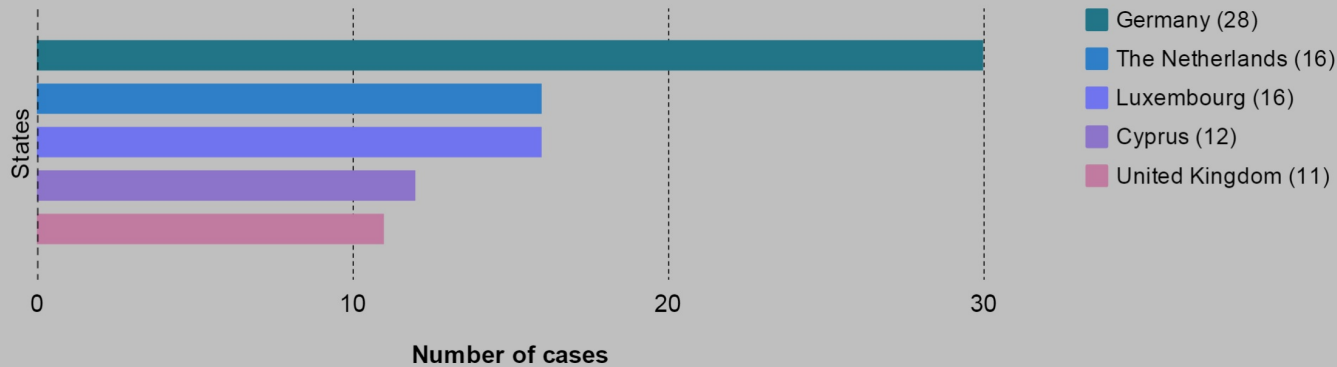
## Top 5 Respondent States



# Claimant: Country of incorporation or nationality

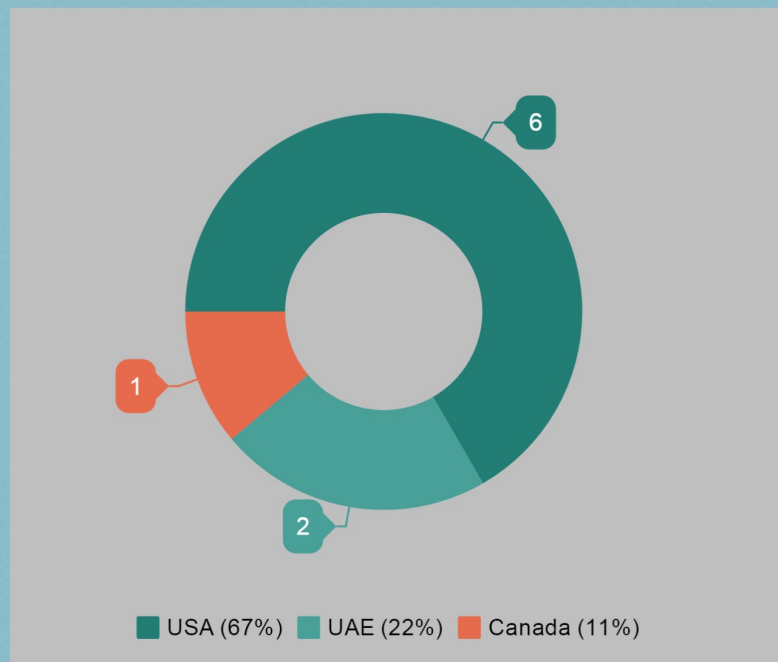

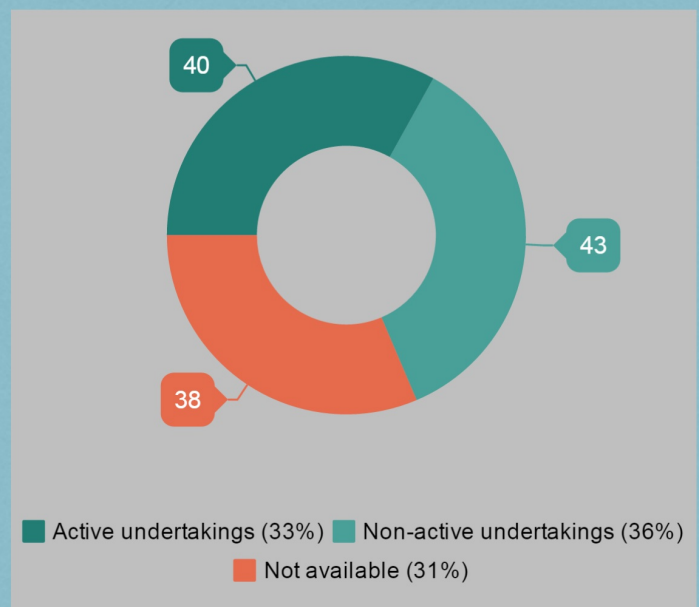
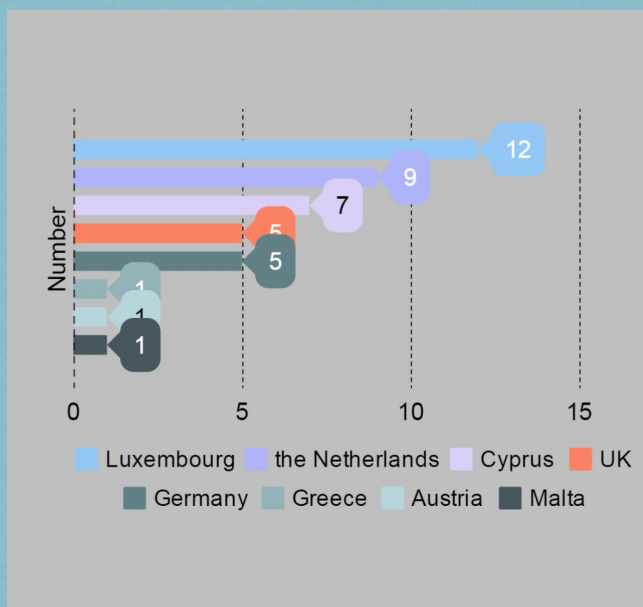


## Treaty shopping\*

Claimant is owned or controlled by non-ECT investor



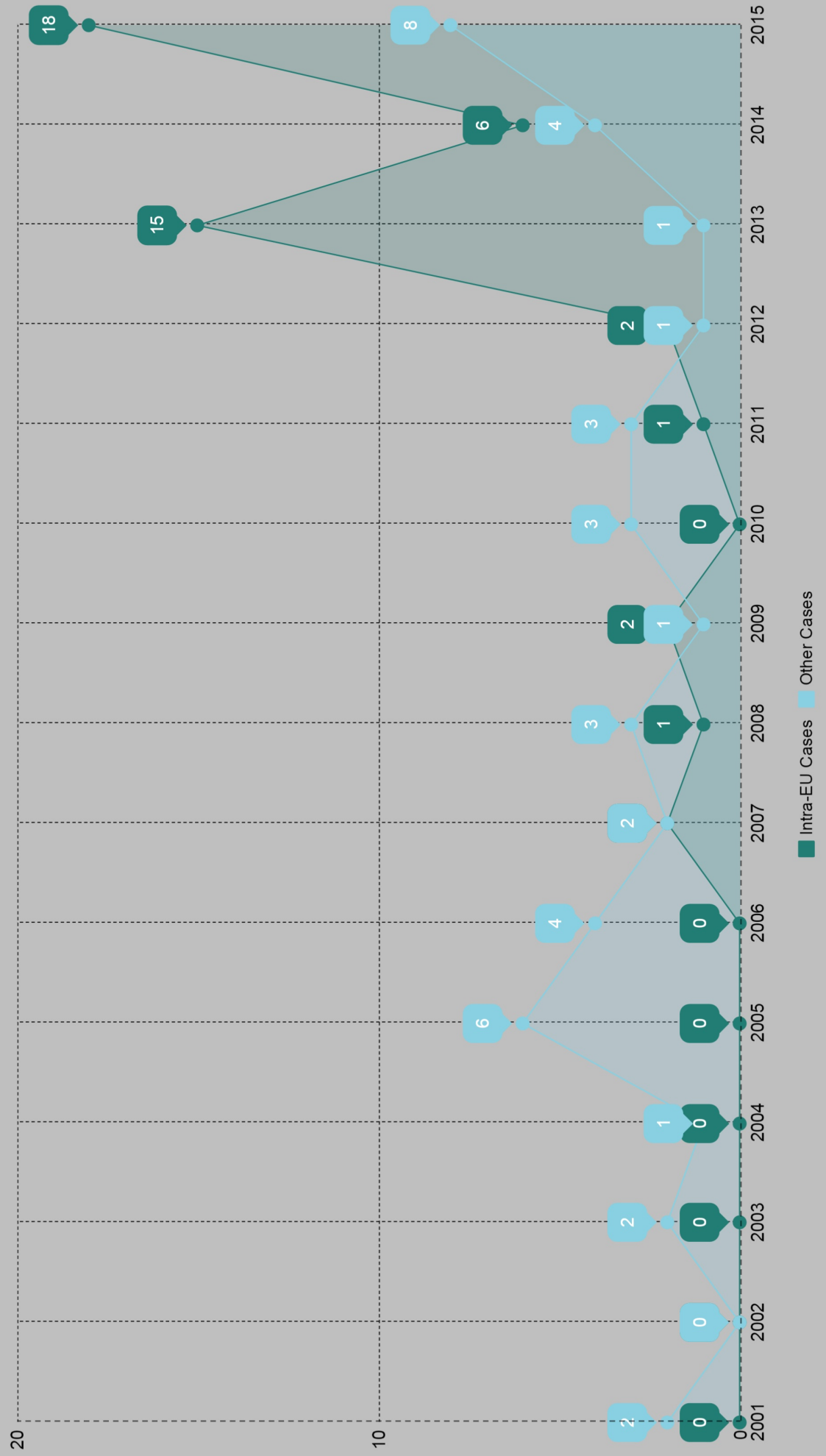
Claimant appears to have no substantial business in the country where it is incorporated

## Focus: EU Investors against EU Member States

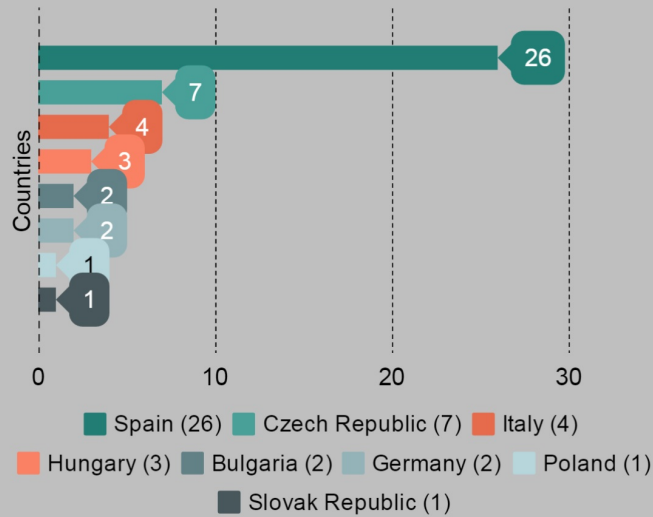




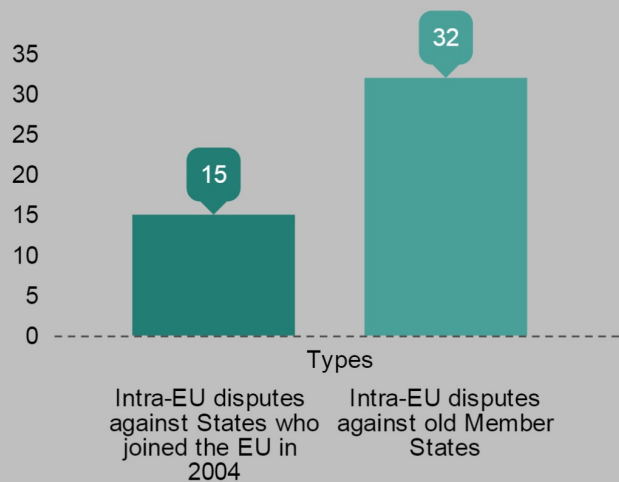

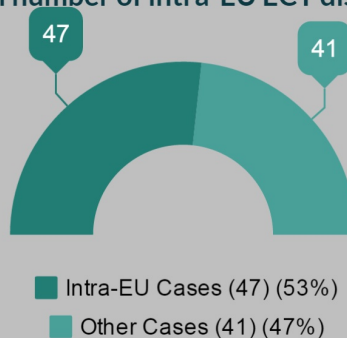
Top 5 Respondents: Intra-EU investment disputes

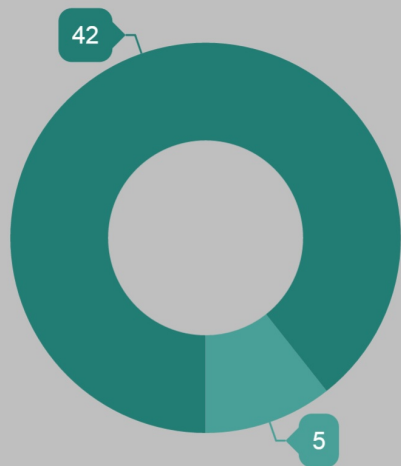


Intra-EU ECT disputes



Total number of intra-EU ECT disputes

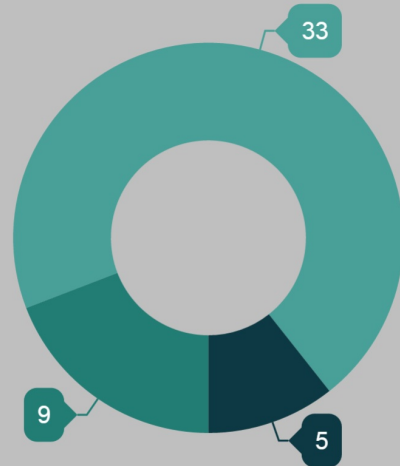
