In general, innovation "eco-systems" make innovation happen in a region / country. Such innovation eco-systems work thanks to the combination of public support and private initiative and depend crucially on the interaction and openness to

cooperate among the different enterprises, citizens, educational research public etc. bodies. Public policy and funding cannot create top-down such innovation eco-systems, but can increase the likelihood for such an innovation-friendly setting to emerge and evolve. Fostering the emergence or improvement of such innovation eco-systems and sharpening their unique features was part of the smart specialisation approach.
