Session II 'Rebooting Economic Growth in terms of social and environmental sustainability'

And a fair and free social structure, that provides equal rights, justice, freedom and democracy. It is needless to say that these three elements should strengthen each other, instead of affect each other in a negative way.

That is why I am very happy with the priorities of the Italian G20-presidency, the three P's, and its efforts to regard these three elements as inter-connected pillars.

Allow me to shortly turn back to our discussions two years ago during the P20 Summit that took place in Tokyo, Japan. We spoke about our future societies: how digitalisation, robotisation and big data will change the way we work, the way we interact and the way we live. Economically, environmentally and socially.

To be prepared to have the knowledge, the facilities and the ability to oversee the consequences of technological innovation, to scrutinize our governments and to also become the parliaments of the future.
